COURSE TITLE:	FIREARMS TACTICAL RIFLE ADVANCED (AR-15/M16)			
OVERVIEW:	<p>This course is designed for sworn law enforcement personnel authorized to carry and utilize carbine rifles while in the performance of their duties. This is <u>not</u> a basic rifle course. Students must possess a basic proficiency with their weapon prior to attending this course.</p> <p>Topics and practical exercises covered in this course include cover and concealment shooting, moving target drills, transition drills, reloading drills, varied shooting positions, shooting on-the-move, weapons equipment and practical accessories, and a legal and civil overview of lethal force use.</p>			
PREREQUISITE:	<p>Must be currently employed by a law enforcement agency as a sworn peace officer. <u>Must have successfully completed a 16-hour P.O.S.T. certified basic rifle course or equivalent.</u> Also, see required equipment listed below.</p>			
ADDITIONAL COURSE INFORMATION:	<p><i>Students will be required to pass a 50-round rifle qualification course on the first day. The qualification shoot shall consist of a static line shoot firing at turning targets from the 50-yard line to the 3-yard line. A minimum score of 90% (450 points) shall be attained. Students will also be required to take a 21-question rifle manipulation test. A minimum score of 90% shall be attained. This is a requirement by P.O.S.T. Participants who fail to qualify the shoot or fail the manipulation test will not be allowed to continue with the course.</i></p>
